

Terms of Service

Effective Date: August 29, 2025

These Terms of Service (“Terms”) govern your access to and use of the GZTV platform, owned and operated by the parent company Burgest Graham, LLC (“Company,” “we,” or “our”). By downloading, accessing, or using the app, you agree to be bound by these Terms. If you do not agree, you must not use the platform.

1. Eligibility

- The platform is intended for individuals 13 years and older.
- If you are under 18, you represent that you have permission from a parent or legal guardian.

2. Content Ownership

- All video content made available on the platform (“Content”) is owned by the credited productions, licensors, or creators.
- The Company does not claim ownership of third-party Content and serves solely as the host and distributor under license from the rightful owners.
- Company-created or original works are separately credited as owned by the Company.

3. License to View

- Subject to these Terms, the Company grants you a limited, non-exclusive, non-transferable, revocable license to access and view the Content solely for personal, non-commercial use.
- You may not reproduce, download, copy, modify, distribute, publicly display, or create derivative works of the Content without express written authorization from the credited owner.

4. Prohibited Uses

You agree not to:

- Record, capture, or redistribute platform Content without permission.
- Circumvent, disable, or interfere with security features.
- Misuse the platform for unlawful purposes.
- Engage in harassment, hate speech, or abusive behavior if interactive features are available.

5. Intellectual Property Rights

- All Content remains the exclusive property of the credited productions or licensors.
- The GZTV brand, trademarks, logos, and platform software are the property of the Company and may not be used without authorization.

6. Moderation and Enforcement

- The Company reserves the right to suspend or terminate access to the platform if these Terms are violated.
- Reported misconduct, infringement, or unlawful activity may be referred to rights holders or legal authorities.
- The Company acts as a moderator only and does not guarantee the completeness, accuracy, or availability of any Content.

7. Privacy

- The Company collects and processes user information in accordance with its Privacy Policy.
- Users may not share personal, financial, or sensitive data through the platform.

- Content may include sensitive or mature themes suitable for ages 13 and older. Viewer discretion is advised.
- The platform is provided “as is,” without warranties of any kind, to the fullest extent permitted by law.
